4. Discussion and Possible Action on the minutes from February 9, 2024, meeting.
5. Recommendation to rescind TARB approval and reschedule a protest previously resolved erroneously by joint motion for PID 810872, to be rescheduled for a valuation hearing in June 2024 for the prior year 2023. Agent was not authorized to represent.
6. Recommendation to rescind TARB approval on February 9<sup>th</sup>, 2024 for PID 167142. Panel Denied hearing for taxes not paid although Property owner paid portion of the undisputed amount. The protest was dismissed in error. The protest for under sec 25.25(d)(2) for 2023 will be rescheduled in June of 2024.
7. Recommendation to rescind TARB approval on February 9<sup>th</sup> for PID 534838. Property owner was denied an exemption by TCAD in 2024 and appropriately filed a challenge to protest the denial for 2024. The panel changed the protest year from 2024 to 2023 erroneously. The protest for 2024 exemption denial should be rescheduled in June of 2024.
