The following motion was made by Ms. Langley: That Dr. Fidelma O'Leary, the owner of PID 306483, having sworn under oath that she never authorized Property Tax Protest to serve as her authorized agent, I move that the action in the Joint Motion dated July 16, 2025 of the Chief Appraiser and Property Tax Protest as to PID 306483 be nullified, pursuant to Texas Property Tax Code Section 41.01(a) and 41.47(g-1); the Order Determining Motion for PID 306483 be withdrawn; and PID 306483 be considered in a hearing before the Travis Appraisal Review Board and a new order issued following this hearing. The motion was seconded by Ms. Gilmore. The motion passed with no nays or abstentions.

The following motion was made by Ms. Gilmore: That the following appraisal records of the Travis Central Appraisal District, as reviewed and corrected by the Travis Appraisal Review Board (Board), be approved and that they constitute the 2025 appraisal roll for the Travis Central Appraisal District pursuant to Section 25.24, Texas Property Tax Code: (1) those records on which no protest was filed; (2) those records on which a late protest was filed without good cause, as determined by the Board; and (3) those records on which a protest was filed, a final determination made, and a correction order issued; and that the records on which a protest has not been determined are excluded from approval and the Board retains jurisdiction over those records.
